The Guam Housing and Urban Renewal Authority (GHURA) is requesting public comment regarding the proposed Substantial Amendment to the PY2019 Annual Action Plan (Guam CARES Act Amendment), and the reprogramming of COMMUNITY DEVELOPMENT BLOCK GRANT-CORONAVIRUS (CDBG-CV) funds from completed and canceled projects to on-going and new projects.
