Biden: Inflation battle to be 'top priority'

WASHINGTON (The Washington Post) — President Joe Biden on Tuesday night sought to assuage Americans about the trajectory of the U.S. economy, pledging in his first-ever State of the Union address that his "top priority is getting prices under control."

Speaking from the dais of the House, Biden began by emphasizing that jobs have returned, wages have risen and the country has resumed many of its daily rhythms under his watch, roughly two years after the coronavirus pandemic touched off the worst economic crisis since the Great Depression.

But the president also acknowledged that millions of Americans still

face financial hardships, particularly as the cost of groceries, gasoline, cars and rents have skyrocketed in what has become the fastest period of inflation in four decades. On a day when geopolitical tumult threatened additional shocks, Biden promised fresh vigilance in Washington to protect families at risk of falling further behind.

"With all the bright spots in our economy, record job growth and higher wages, too many families are struggling to keep up with their bills," Biden said. "Inflation is robbing them of the gains they might otherwise feel."

"I get it," Biden continued. "That's why my top priority is getting prices under control."

Specifically, Biden called on

Congress to support a series of economic initiatives, including efforts to provide monthly tax payments for families with children, reforms

to lower prescription drug prices for seniors, and legislation to raise the minimum wage for millions of workers. The president vocalized anew his plans to address logjams in "global supply" chains that have driven up demand for some goods, like automobiles, leading to higher prices. And he promised to combat corporate conglomerates, which he said may be squeezing consumers through price gouging.

Many of Biden's ideas originated in a slew of blueprints he has unveiled since assuming the presidency, including a signature initiative known as the Build Back Better Act, which ultimately faltered last year because of divisions among Democrats.

Abbott, O'Rourke to face off in contest for Texas governor

WASHINGTON (Reuters) — Republican Texas Gov. Greg Abbott won his party's nomination on Tuesday to seek a third term in office, setting up a November contest with Democratic former Congressman Beto O'Rourke, U.S. media reported.

Abbott, who was endorsed by former President Donald Trump, easily turned back several right-wing challengers, will enter the general election as a favorite over O'Rourke, the state's most prominent Democrat, is seeking to become the first Democratic governor of Texas in nearly three decades.

Texas voters were also selecting their parties' nominees on Tuesday for the U.S. House of Representatives. The first-in-the-nation nominating contests could offer clues about the mood of American voters ahead of the Nov. 8 elections that will determine control Congress for the rest of President Joe Biden's four-year term.

The election is also the first test of new Republican-backed voting restrictions passed in response to Trump's false claims of election fraud.

As of Tuesday evening, there were no reports of long delays or major problems at polling places, following weeks in which several counties recorded an unprecedented number of rejected mail-in ballots due to new identification requirements.

Texas Secretary of State John Scott said Harris County, the state's largest and home to one in six Texans, had informed his office that it would be unable to tally all votes within 24 hours

of the polls closing, as required by law.

The delay is due to "damaged ballot sheets" that must be copied before they can be scanned, Scott said in a statement, adding that his office would offer assistance as needed.

A Harris County election office spokeswoman declined immediate comment

Midterm elections typically serve as a referendum on the sitting president, and Republicans are favored to win a majority in at least one of the two chambers of Congress that Democrats control by razor-thin margins. That would allow Republicans to block Biden's legislative agenda and launch investigations that could damage his administration.

Biden, whose public approval

remains at a low 43%, according to a Reuters/Ipsos poll completed on Tuesday, delivered his annual State of the Union address in the evening.

The Republican race for attorney general may provide an early measure of Trump's power among the party's faithful. Ken Paxton, the incumbent, is running for a third term with Trump's backing, despite his pending 2015 indictment for securities fraud and a separate federal investigation into allegations of bribery. Paxton has denied any wrongdoing.

He held an early lead over Land Commissioner George P. Bush, grandson of former President George H.W. Bush, firebrand U.S. Rep. Louie Gohmert and former state Supreme Court Justice Eva Guzman.

Oil prices reach \$126

(Reuters) - Oil prices seesawed Tuesday with Brent crude reaching \$125 per barrel, around 10% below a 14-year high struck in the last session, reflecting relief that European allies were not planning to join a possible U.S. ban on Russian oil imports.

Brent crude futures were up \$2.01 at \$125 a barrel Tuesday after trading as high as \$126.35.

U.S. West Texas Intermediate crude futures were up \$1.53 at \$120 a barrel.

'Unless the war stops, (Brent) prices can go anywhere towards \$156 to \$185 a barrel, said Ajay Kedia, director at Kedia Commodities in Mumbai.

If all of Russia's oil exports were blocked from global markets, analysts have said prices could rocket to \$200 a barrel, while Russia's Deputy Prime Minister Alexander Novak said oil could soar to more than \$300.

"There is no capacity in the world in the moment that can replace 7 million barrels of exports," OPEC Secretary-General Mohammad Barkindo told reporters at an industry conference in Houston.

A year ago, U.S. oil traded for \$50 a barrel, according to the U.S. Energy Information Administration.

Friday, March 11, 2022** at the GHURA Sinajana Main Office, 1st floor Conference room, by Chairman Rivera. He indicated that **6** members of the Board of Commissioners were present, representing a quorum and that the meeting would proceed as scheduled.

Before roll call, Chairman Rivera expressed his sincere gratitude to the GHURA family for the care that it had taken to show their respect and to honor the former Director Topasna. [018/22] Commissioner Ishizaki moved to adopt the meeting minutes of February 25, 2022, as corrected. The motion was seconded by Vice Chairwoman Guzman. There were no objections by the other board members. The motion carried.

IV. OLD BUSINESS

1. [019/22] LIHTC 2021 Application, Panel Results and Recommendation (Ongoing Discussion) Ref: Minute No. 183/32 & 184/21

Acting Executive Director Napoli deferred to Ms. Katherine Taitano, GHURA Chief Planner. Ms. Taitano stated the following:

- Back in November, two projects were brought before the BOC, Summer Breeze and Summer Vista.
- Both projects met the minimum requirements for approval.
- There was not enough funding for both projects to receive full credits, as requested.
- The panel review favored the smaller project, Summer Breeze.
- Additional credits were awarded to an ongoing project, Villa Del Mar. This was also approved.
- Balance from the funding remained available.
- It was at the request of Commissioner Ishizaki and the board to explore the opportunity to pursue funding to Sumer Vista as the project also met the minimum requirement.
- Ms. Taitano's team had explored various ways to maximize the balance of the Qualified Allocation Plan (QAP).
- The Summer Vista project, if amended, could bring in 96 units of 128 units, which was Summer Vista's original proposal.
- Additional funding to complete the original proposal of 128 units may come from the Build Back Better initiative which requires congressional approval.
- GHURA has received the revised amended packet from Summer Vista which includes the scaled down proposal of 96 units.
- None of the provisions that were subject to the approval process for the selection criteria were changed.

Commissioner Ishizaki requested that Ms. Taitano provide the board with the balance of the remaining funds. Ms. Taitano stated that in 2021 QAP, the LIHTC Allocation Competition there was \$6.6 million available. GHURA awarded Villa Del Mar II \$336,000 of additional credits and \$3.6 million to Summer Breeze for 64 units. What remained was \$2.4 million of the 2021 and \$2.9 million of the 2022 QAP, LIHTC Allocation Competition. A total of \$5.4 million that is available, is sufficient for the 96 units.

Vice Chairwoman Guzman asked that although Summer Vista agreed to build 96 units for \$5.8 million, could they build 128 units. Ms. Taitano stated that Summer Vista could not build more than the 96 units at that price. However, Summer Vista had expressed their willingness to finish building the original proposed 128 units should more funding become available. Ms. Taitano added that awarding to Summer Vista would be acknowledging the reality of the challenges of finding units sufficient for the market that is needed. While also acknowledging the escalations in rent that are displacing families. Ms. Taitano added that Summer Breeze would be building 64 units and Summer Vista would be building 96 units.

Vice Chair Guzman asked that Ms. Taitano explain the additional points that were awarded to Summer Breeze. Ms. Taitano stated that they try to encourage developers to build in areas other than the Northern areas. Clients of affordable housing face the challenges of job availability found mostly in the Northern and central areas. She added that her team looked to other areas as much as they could. It was an opportunity to build in Barrigada.

Chairman Rivera inquired about the anticipated timeline of when these units would become available to the market. Ms. Taitano stated that the units should be available within two years. She added that the developers face very strict deadlines because the tax credit aspect is managed extremely well.

Vice Chair Guzman asked when the 2023 allocation would be awarded. Ms. Taitano indicated that she and her team should know towards the end of 2022. Vice Chair Guzman indicated that construction of Summer Vista would be into about one year of construction. Ms. Taitano confirmed this and clarified that she and her team are hoping for the additional allocation out of cycle of the Biden Administration's Build Back Better Initiative. Ms. Taitano stated that there may still be an opportunity for the initiative to make its way back into legislation in some smaller form and maybe a more targeted form, just for tax credits. Should that be the case, GHURA may use those additional funds to pursue with the developer to complete the 128 units. Currently, GHURA is not looking at forward allocations of 2023. Vice Chair Guzman stated that perhaps additional funding may be found elsewhere. Ms. Taitano added that it may be possible and stated that her team was looking into all sorts of ability opportunity to use the Home American Rescue Plan allocated funding for the island for a project that involved the tax credits. There were lots of examples of using HOME funds with a tax credit project. Home Program allocations are on the smaller side, far smaller. \$3.8 million is available to GHURA under a Home American Rescue Plan allocation, but Home has many requirements, and this is new territory for them. Ms. Taitano stated that for the VISTA project, it was something that she was uncomfortable at this time to pursue. However, they do have another cycle coming up and

the timing might be better for that sort of thing. She added that they would find something to use the Home AARP monies on.

Vice Chair Guzman inquired about whether legal counsel had reviewed the document. Ms. Taitano stated that legal counsel had not reviewed the revised application. She stated that she and her team looked at it against the original selection criteria and that the points adhered to all the same requests and requirements. They stayed to the line.

Chairman Rivera inquired about whether the initial approval process done in 2021 was still legitimate since this was a new cycle and additional funding source was from a different year. Ms. Taitano stated that there was nothing to preclude the board from utilizing available 2022 funds to further projects which were awarded in 2021. They would carry on into 2022. Chairman Rivera stated that for clarification purposes that project one of two was already funded and that this would be project two of two. Ms. Taitano confirmed this and added that GHURA chose not to wait another year before going out for applications while a perfectly viable project was available. And it was at the request of the board to go back and see what could be done to make things move.

Commissioner Corpus asked if there was a deadline to vote on this item and added that he would feel more comfortable if legal counsel would review it and the board vote on it at the next scheduled meeting. Ms. Taitano stated that if it was the board's wish to have counsel review the document, then her team will provide it for counsel's review. She added that counsel does review all documents for execution of agreements with the developers selected. Ms. Taitano stated that there was no deadline to meet, but that any delay would have impacts on projects started.

Commissioner Sanchez inquired about whether there were other developers aside from CoreTech and Ironwood that applied and met the criteria. Ms. Taitano stated that there were only two applications and that both were under the Summer umbrella projects. She added that Ironwood was a previously approved project and needed additional funding. Ms. Taitano indicated that she recently received an email from a new developer.

Chairman Rivera stated that there were two options before the board, a request for approval to proceed; or have legal review and push for a vote at the next scheduled board meeting. He added that based on his understanding that even if the board approved the item, it would still need to be reviewed by legal counsel with those developers. Ms. Taitano stated that legal counsel would have to review anything that requires the signature of the executives. She also stated that it would only be the board's approval that would get the projects started and should legal counsel find any issues, the board will be notified.

There were no further discussions.

[020/22] Commissioner Sanchez moved to have legal counsel review the document and allow board members to reiterate what was discussed today and reach a consensus before finalizing. Vice Chair Guzman seconded the motion. There were no objections by the other board members. Motion passed.

V. CORRESPONDENCE AND REPORTS

1. [021/22] MIS Status of Agency Transparency and Open Government Law

Mrs. Julie Lujan, MIS Manager, stated the following:

- Open Government Law information packet was received by GHURA from the Attorney General's Office (AG's Office)
- Notes provided pertained to the interactions that the MIS division deals with.
- Other items that pertain to reporting and compliance are taken care of on the Executive/ Admin. side.
- The purpose of the Open Government Law is to ensure that all government agencies are compliant as far as disclosing information to the public.
- The document provided came out in December 2021.
- Document states that the board may participate in the use of video teleconferencing at meetings. GHURA has the Zoom video teleconferencing platform in place.
- GHURA has made it possible for the Public to participate in the video teleconferencing.
- Agency Homepage- For accountability and tracking, GHURA has had an agency homepage for 10+ years. Board announcements, board agendas, and GHURA events are available for review as far back as January 2017.
- Video Live Streaming at meetings- this is now mandatory. GHURA has its channel available on YouTube. Meetings can be streamed live. Once meeting ends, recording is placed for historical purposes on the GHURA channel.
- Public Notices- another area that GHURA must report to. A website was created by OTECH. After several earlier attempts at developing a relationship with OTECH, GHURA was finally able to have OTECH post on the Guam Public Notices Portal its upcoming events and information regarding BOC meetings.
- Compliance with Americans with Disabilities Act- GHURA has always abided by the Title 2 of the ADA. GHURA's website is ADA compliant as well as Web Content Accessibility Guidelines compliant. TTY number is advertised as well as the ADA Coordinator.
- Source of payment for advertisements- paid for by GHURA funds
- Post meeting requirements- audio provided to OPA; final board packages are sent to the Speaker of the Legislature, to the Governor of Guam, and to the Guam Legislature Messages and Communications. GHURA is compliant with all 3 requirements.
- Video teleconference or face to face attendance- to be included in the board packet.

All email communications or text messages are subject to FOIA requests.

Chairman Rivera thanked the MIS division for being proactive and keeping the board informed. He added that the process in ongoing and evolving and adapt to the way the laws and policies are shift.

Vice Chair Guzman asked what type of committee the Vigilance Committee was. Mrs. Lujan stated that the committee was with Mr. Lee Webber and Senator Klitzky and believed that it was more of a political watchdog group to keep the government agencies transparent.

Commissioner Ishizaki indicated that Mrs. Lujan mentioned email, personal email, and text messages may be subject to FOIA requests. He presumed that Whatsapp text messaging was included. Mrs. Lujan confirmed this. Commissioner Ishizaki suggested the idea of possibly using official phones. Acting Executive Director Napoli indicated that she had requested that Mrs. Lujan seek legal counsel regarding the issue of using personal devices for official business and will update the board with information later.

Chairman Rivera stated that those forums are used for informational settings only, such as sending out announcements or reminders. It should not be used for deliberations of any kind or to garner any sentiment about decisions. Chairman Rivera stated that the board chat has only been used for informational purposes and announcements and recommended that the board continue to use the chat in this way. He agreed with Acting Director Napoli that consulting with legal counsel about this issue would be in the best interest of GHURA and of the board of commissioners.

Vice Chair Guzman asked Mrs. Lujan if GHURA has its own servers. Mrs. Lujan stated that GHURA has 10 servers and is not connected to the GovGuam Wide Area Network but continues to remain compliant.

There were no further discussions.

SUBJECT: LIHTC 2022 Tax Credit Allocation to Summer Vista I

Hafa Adai Director Napoli and Commissioners,

At the regular meeting of GHURA's BoC on November 26, 2021, a motion was made by Commissioner Pereda and seconded by Commissioner Delia to approve the award of additional LIHTC Credits in the amount of \$197,832 for the Villa Del Mar II, LLC¹ project and the new award of \$3,663,526 to Summer Breeze I, LLC².

The Board further directed management to examine the possiblity of awarding the balance of the available tax credits to support bringing additional affordable units online soonest, acknowledging the earnestly increasing need for affordable units. Commissioner Ishizaki recommended to continue negotiations with Summer Vista I developer Core Tech Development to see if it is viable to continue the project with the amount of credits available.

The breakdown of credits available from 2021 and now also 2022 are listed below.

Credits Available LIHTC 2021 6,660,957 LIHTC 2019 (National Pool) Returned \$ (197,832)LIHTC 2021 Additional Credits (VDMII) (336,200)\$ LIHTC 2021 Award (Summer Breeze) \$ (3,663,526) LIHTC 2021 Allocation Remaining 2,463,399 LIHTC 2022 Allocation 2,975,000 Credits Available LIHTC 2022 \$ 5,438,399

Presently, the amount of tax credits available to be allocated by the GHURA Board of Commissioners for LIHTC proposed projects is \$5,438,399.

GHURA met with Summer Vista, LLC representatives on two occasions.

- On January 13, 2022, Core Tech Development³ met with GHURA staff to consider options for the award of available tax credits, possibly to include HOME American Rescue Plan funds. Four ways were contemplated:
 - 1. HOME funds as a market-rate loan direct to the project
 - 2. HOME funds as a below market-rate loan with 9% credits utilizing the 40/50 rule and no basis boost for QCT/DDAs
 - 3. As a below market-rate loan with 4% credits (require use of tax exempt bonds which GHURA does not administer or acquisition projects)
 - 4. As a Grant from GHURA
 - Direct Grant to the Owner/Developer
 - While HOME funds can be awarded as a grant, this would likely result in a reduction of the project's Eligible Basis under LIHTC. Grants are almost always treated as taxable income opening the possibility of significant tax consequences from the LIHTC perspective.
 - Direct Grant to Guam Facilities Foundation, Inc. (non-profit entity providing property management services to CTD-constructed LIHTC properties) for the purpose of lending the grant money to the development.
 - A grant to GFFI may address the issue of a reduced Eligible Basis and is unlikely to incur negative
 tax consequences. However, the requirements of HOME as financial investment in a LIHTC project
 is unknown. GHURA's due diligence to ensure HOME program regulations are met could impact
 the development schedule.
- On February 17, 2022, Summer Vista, LLC representatives and GHURA staff, after evaluating options concluded the following:
 - A LIHTC/HOME mixed financing structure may not be achievable given the timeline expectations of the LIHTC component at this time.
 - o A LIHTC-only financing for the Vista project to utilize 2021/2022 tax credits could develop 96 of the 128 units originally proposed.

As of March 07, 2022, Summer Vista I submitted an amended/updated application to reflect the reduction of units from 128 to 96. The updated application represents a scaled down proposal with no changes to any of the previously reviewed selection criteria elements. The Summer Vista I updated application requests to utilize the full amount of \$5,438,399. Should the IRS increase the allocation to LIHTC jurisdictions at some later time in 2022, Summer Vista I may request an allocation of additional credits for the purpose of completing 128 total units.

Approval by the GHURA Board of Commissioners is required at this time to award LIHTC program tax credits to Summer Vista, LLC in amount of \$5,438,399 for the development of 96 affordable housing units as proposed in their amended/updated application.

At the Regular Board Meeting of March 11, 2022, a motion was made by Commissioner Sanchez and seconded by Vice Chairwoman Guzman to approve the award of LIHTC program tax credits to Summer Vista, LLC in the amount of \$5,438,399 for the development of 96 affordable housing units as proposed in the amended / update application under the notion that Legal gets final review and the Board reach a consensus. Without any further discussion and objection, the motion was approved.

"OPEN GOVERNMENT LAW IN GUAM"

- 1. Purpose of Open Government is to ensure all government agencies are compliant with disclosure laws. Its efforts are to confirm each entity is transparent in reporting and allowing the public accessibility to agency information.
- 2. The Vigilance Committee (President Lee Webber) goal is to provide "the people's right to know the process of governmental decision-making and to review the documents and statistics leading to these determinations". It is "key to holding public officials and government representative accountable".
- 3. Attorney General (Leevin Camacho) Open Government Law was issued December, 2021 to all Gov Guam agencies to ensure reporting requirements are met. In part the policy includes, "the people insist on remaining informed so that they may retain control over the instruments they have created".

For MIS, these requirements included video teleconferencing, agency home page, video live stream applications, Government of Guam Public Notices Portal, compliance with Americans with Disabilities Act (ADA), website message regarding government funds, audio to Office of Public Accountability, and finally, email communications subject to FOIA (informational only).

- 4. Prior to Open Government Law issued by the Attorney General, and relating to the Vigilance Committee requirements, GHURA had been in full and confirmed compliance. Post Open Government Law GHURA had two outstanding requirements to fulfill, 1) to make available all notices to the Government of Guam Public Notices Portal, and 2) video live stream applications. To date, these two requirements as well as all others are being met that require MIS interactions.
- 5. The included attachments are twelve (12) pages of information relating to Open Government Law as it relates to the MIS division.

The Legislature declares it is the policy of this Territory that not be conducted in secret. The people of Guam do not yield their individual rights to the public agencies which serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments the formation of public policy and decisions is public and shall they have created.
