Questions & Answers:

1. What is the required delivery date and if the date is not met, is GHURA amenable to working on a flexible ETA delivery date?

- **GHURA response:** Yes, due to industry delivery delays caused by COVID-19, GHURA will extend the delivery date to 120 days After Receipt of Order (ARO).
- 2. Does GHURA check on the vendor capability on the repair/service the appliances? If so, how does GHURA guarantee that vendors have the ability to repair/service the appliances?
 - **GHURA** response: GHURA requires a certification/warranty from bidders that the appliances are covered up to 1 year.
- 3. When was the last time the bid specifications were updated?
 GHURA response: Only the appliance sizes were recently updated after conferring with Property Site Managers.
 - *Vendor recommended for specifications to be updated due to existing specifications being outdated; manufacturers no longer providing appliances based on those specifications.
